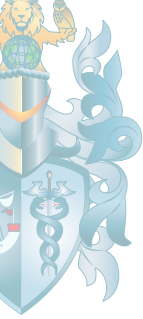

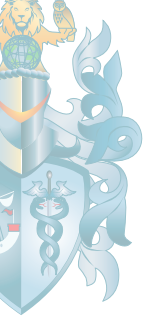

Mandy Clifford *BAE Systems (Operations) Ltd*

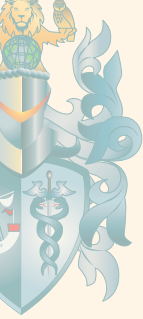
Level 4 Diploma in International Trade Prize

“From a personal perspective I have found the course challenging and interesting and it kept my mind busy during the pandemic – definitely helped me through the lockdowns,” Sue concludes.

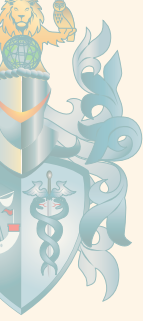
Feras Alhumidi *Saudi Export Development Authority*
